**Description of Reasonably Foreseeable Impact of the Planned Changes:**

After retirement of the copper facilities, CBT will (1) no longer offer services over the copper facilities; and (2) cease maintaining copper facilities. All services previously provisioned over copper facilities to affected customers will continue over fiber facilities. There are currently no interconnected telephone exchange providers in the affected area. There are 211 CBT customers in the addresses affected by switch retirement. CBT is actively working to move these customers to fiber facilities, thus there should be no impact of a due date of over 90 days.
