Wright, Kentucky Optical Remote Module (ORM) FTWRKYAARS0. This ORM's host is Lakeside Park, Kentucky 5ESS Switch LKPKKYLPDS0. As a result, the Ft. Wright ORM will be retired and customers will be served by the CBT Metaswitch EVDLOHEVPS2 located in Evendale, Ohio.</p>		
Description of type of changes planned:		
<p>The City of Ft. Wright, Kentucky has informed CBT that they will not renew the lease for the building housing CBT's Ft. Wright, Kentucky ORM FTWRKYAARS0. This ORM's host is Lakeside Park, Kentucky 5ESS Switch LKPKKYLPDS0. Therefore the Ft Wright, Kentucky ORM, located at 409 Kyles Lane Ft. Wright, Kentucky will be retired and removed from the network after all customers served by this ORM are migrated to the CBT Metaswitch EVDLOHEVPS2 located at 10000 Reading Road Evendale, Ohio.</p>		
Description of Reasonably Foreseeable Impact of the Planned Changes:		
<p>Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will continue to maintain facilities and send traffic to the Host</p>		

Switch, Lakeside Park, Kentucky LKPKKYLPS0 and will not need to secure new trunk groups to the Evendale, Ohio EVDLOHEVPS2 switch or augment existing trunk groups to that switch. New ASRs will not need to issued. New services will continue to be ordered by service address as they are currently are today.
